Registration mares

The mare that will be inseminated must be registered at the Feif. Proof should be provided in the form of a clear copy of the parentage document. Applications need to be sent by email to: info@enclavehof.be

2. Breeding season

The breeding season starts on 1 April and ends on 30 September 2021.

3. Procedure semen

- A. Semen can be either collected or delivered. Frozen semen will be shipped after consultation with the mare owner.
- B. For each dose of semen, the mare owner will receive a semen ticket / insemination certificate. This should be completed and signed by the veterinarian and returned to Van 't Enclavehof by
- C. Per mare a maximum of 5 straws is provided per heat cycle.
- D. A dose of frozen semen for a future cycle can only be obtained when the logistic costs have been paid.
- E. The mare owner should return the insemination certificate within 60 days after the last insemination, and this should include the confirmation of gestation or proof that the mare is not pregnant. In case there is no pregnancy, the declaration should be provided by the veterinarian.

In case the breeder neglects to inform that the mare is not pregnant, the pregnancy supplement will automatically be charged.

4. Settlement stud fee.

The amount of the stud fee should be settled as follows:

- A deposit of € 300,00 + VAT when ordering
- The pregnancy supplement is due when the mare is confirmed pregnant 60 days after the last insemination

The pregnancy supplement = Fee according to the assessment of the mare.

- 5. By ordering and sampling semen, the mare owner declares to have read these conditions and to completely agree with these breeding and payment conditions as well as with the stud fees.
- 6. In case the mare owner attempts to fraud, an unconditional fine of \leq 2500,- (excl. 21% VAT) should be paid per case, next to the equally due stud fee.
- 7. The mare owner must return the insemination certificate, mentioning the last insemination date, to the office of Van't Enclahof by Langenberg 37, 2323 Wortel, Belgium.

If the mare is pregnant, the mare owner will receive, at his/her request and after payment of the pregnancy supplement, a cover certificate / birth notification mentioning the last insemination date.

8. Fees

€ 900 plus VAT = mares judged FIZO >8.00

€ 1.000 plus VAT = mares judged FIZO >7.80

€ 1.100 plus VAT = all other mares

+ logistic costs (rent container + shipment container)

Live foal guarantee: this implies that the covering must result in a viable foal that survived the first 24 hours after birth.

Other fees:

Fee stabling costs: 15 € per dag + BTW

Reminder fees: 10 €

Collection expenses: 20% with a minimum of 100 € per case

Veterinary costs

VAT on semen : Animal products used for reproduction, 6% all other acts 21 % vat

9. Packaging/containers

The frozen semen is delivered in an appropriate container owned by the EU certified breeding station Twinkeling or in your own container. The Twinkeling container should be returned by the mare owner within 7 calendar days and costs should be borne by the mare owner. From the 8th day onward, a rent of $\,\in$ 25,- per day per container will be charged. This rent remains due until final return of the container. The return date is always the day the container arrives back at Twinkeling.

10. Health Certificates

For orders from abroad Twinkeling arranges the necessary health certificates. If semen is ordered more than once on the same cycle for a mare, then the extra costs will be charged to the mare owner.

11. Invoicing / payments

Payment of invoices from Van 't Enclavehof by should be done within 15 days after the invoicing date. When the payment term is exceeded, the invoiced amount will be increased with reminder fees and penalty interest as well as potential collection costs, both judicial as extrajudicial.

12. General

All rates are exclusive VAT, transport costs, veterinary costs and health certificates.

The transport is at risk of the receiver.

It is not allowed to resell straws!

The breeding conditions remain in force at all times, the buyer is responsible for keeping in compliance with these conditions.

By ordering and receiving semen, the mare owner has taken note of our breeding and payment conditions and declares to agree with these conditions.
