Every owner of a mare using one of our stallions from our stable acknowledges that he has taken note of the following general mating conditions.

The breeding season runs from 15 April 2025 to 30 September 2025. You are always welcome to visit our stables by appointment. Bringing and picking up mare(s) only by appointment.

The stud station (Twinkeling bv) and our stable are not responsible for damage, illness or injury to people, animals or means of transport. Horses stabled with us or offered for insemination or service always remain under the responsibility of the owner.

Van 't Enclavehof bv offers pregnancy guarantee: guarantee of a live foal. Please bring the passport of your mare to the first mating or when collecting sperm. Live foal guarantee; Live foal guarantee means that the mating should result in a viable foal that has survived the first 12 h after birth.

Veterinary costs for mare counselling are the responsibility of the owner of the mare.

Fresh semen of our stallions can be ordered daily by phone before 09.00 hrs via +32 495 207 087 or +32 476 200 201 or by mail info@enclavehof.be . On Sundays and public holidays, sperm can only be collected after consultation by telephone on Saturdays before 10.00 hrs.

Semen is always sent at the expense of the mare owner. Always keep in mind that stallions may be on competition.

With the first order, all details of the mare and mare owner should be passed on via the stud form. Pregnant mares should be passed on no later than 1 October of the breeding year.

When ordering sperm / mating by hand or in herd, the following information must be submitted to us:

- o The name of the desired stallion.
- o The name of the mare and also a copy of the original studbook paper for records.
- o The name, full address and telephone number of the mare's owner/manager.
- o The full address of the place of delivery if different from the owner's address.

The sperm can be collected after ordering or sent by courier. Transport costs are always the responsibility of the mare owner. We use the services of Hippo - express, this courier service delivers semen throughout Europe.

Payment

An advance of 300 € + VAT on the stud fee must be paid before mating/sending the sperm.= including 1 shipment each additional shipment € 175.00 !

If the mare is pregnant, the rest of the stud fee is paid upon receipt of the invoice for obtaining a stud certificate.

After payment of the full stud fee, we give a live foal guarantee so in case of rejection or a dead foal, you can order sperm again for the mare in question without paying additional stud fee. (see above guarantee of live foal) If the mare does not gestate, sperm from the stallion or from another stallion with the same rate may be ordered the following year without a new deposit. For a stallion with a more expensive rate, one pays the difference of the purchase amount.

Stabling

It is possible to board your mare. This costs € 15.00 per day stabling / grazing € 10.00 per day, however, Van 't Enclavehof bv does not accept any liability towards people or animals regarding illness, injury or damage. If necessary, our vet will be called in, even if the owner cannot be reached. Our team takes optimum care of the well-being of your animal(s). All prices are exclusive of VAT, vet fees transport costs and health papers, unless stated otherwise.

Transport of fresh semen is at the recipient's risk.

We give no guarantee of pregnancy of the mare.

The mare is inseminated at the expense and risk of the buyer/mare owner.

It is not allowed to resell the purchased sperm (straws) without informing Van 't Enclavehof bv in writing.

At all times, the mating conditions remain in force and the mare/owner remains responsible for complying with them.

By signing, the mare owner has taken note of our breeding and payment conditions and declares to agree with these conditions.

It is not allowed to use the purchased sperm for ICSI (intracytoplasmic sperm injection). (If nevertheless interested, please contact us by telephone).

In case of natural mating, the mare owner is obliged to submit the result of the Cem test, if the mare has a foal at foot, a Cem test is not obligatory, unless the mare has been running with other geldings/stallions.

Tariff

VAT 6 % for fresh semen , 21 % for natural mating

+ logistics costs (container rental + shipping of container)

Other rates :

Storage fee : 15 € per day

Reminder fee: 10 €

Collection costs: 20% with a minimum of 100 € per case

Veterinary costs : According to services rendered by our veterinarian.

VAT on semen : Animal products used for reproduction, 6% all other operations 21% VAT.

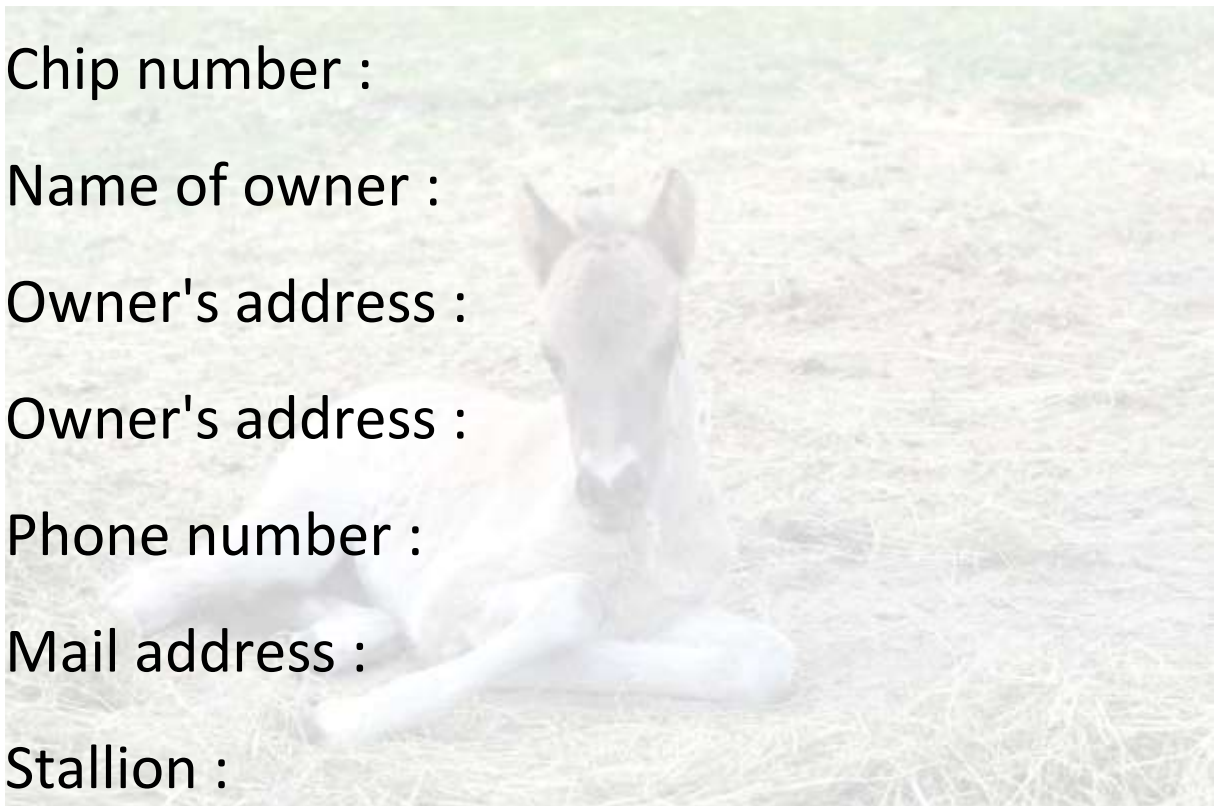
